## Vendor Fair- July 11-14, 2019



Over the course of four days, this historic festival will close streets and fill town with food, live music, presentation and more, celebrating the legendary explorers, fur trappers, and Native Americans who opened commerce in the American West. Vendors interested in a booth space at Green River Rendezvous should fill out the vendor application and submit a completed application and booth fee- vendors will be approved upon completed applications. In honoring the original historic theme, all applications will be reviewed and awarded based on authenticity, quality and relevance to the historic period.

- Applications much include: payment, application, photo of items being vended, proof of insurance before applications will be approved. Vendor applications will be considered based on completed applications, product authenticity, quality and relevance to the historic period. Mail completed application with a check to

- The Sublette County Chamber of Commerce (SCCC) reserves the right to assign final booth location.
- There will be NO REFUNDS for cancellations or no-shows after April 15, 2019.
- NO SECURITY. Vendors are responsible for securing all items, displays etc. related to their booth setup.
- ALL approved vendors must check in at the SCCC prior to setup. NO EXCEPTIONS! Check-In Wednesday July 10th, 2-5 p.m. or Thursday July 11th, 9 a.m.
- All vendors must be closed no later than 9:00 p.m. unless prior location approval and vendors must be completed vending by 3:00 p.m. on July 14th.
- Vendor must be in compliance with all town and state regulations.
- Vendors must provide vendor insurance.
- No individual generators will be allowed.
